Original tax clearance certificates or a Pin must be attached, Both Directors and Company Municipal Rates and Taxes not owed for older than 3 month or lease agreement, CSD Report and Company registration. CIDB grading is 5CE / 4CEPE.

The Bid will be evaluated and adjudicated in line with the approved Supply Chain Management Policy of the Municipality 80/20 preference point system in line with the Preferential Procurement Policy Framework Act 2022 and supply chain regulations. A maximum of 20 points may be awarded to a tenderer for the specific goal specified for the tender.
