INDIGENT REGISTRATION

Qualifying members of Letsemeng Community are urged to register for Free Basic Services, the criteria is as follows:

- Total household income must be equals to or less than R 3500.00
- · Proof of income is required for your form to be accepted
- All Identity documents/ Birth certificate of individual households must be provided to validate your application

Below are the benefits of being registered as indigent household:

- 50 kwh free for Electricity on a monthly basis
- 6000 litres of water free on a monthly basis
- · Free refuse removal service
- Free sanitation services
- Properties up to the value of R 70 000 exempt from Property rates
- 100% Write off of all outstanding debt

Payment of Services

The constitution of the republic mandates local government to provide sustainable services to its citizen, However, for a municipality to be able to provide these services, resources are needed, it on this basis that we request that Community of Letsemeng to pay for their accounts, Municipality is owed collectively over R 200 million.

As a means of assisting our citizens to pay for services, we have initiated Operation Patala campaign, where a discount of up to 50% is given to community members that settle their outstanding accounts in full as a once off payment.
