# APPOINTMENT OF A SERVICE PROVIDER TO INSTALL A NEW ICT INFRASTRUCTURE IN JACOSDAL, OPPERMANSGRONDE, PETRUSBURG and LUCKHOFF OFFICES

#### **BRIEF SCOPE OF WORK**

The service provider is expected to supply, deliver and install all material to be used during the project. A blue Cat6 UTP cable should be used for indoor cabling, the cables should be trunked using pvc trunking. Supply fly leads from patch panel to the network switch. Cabinets should be placed in a lockable office. Install a circuit breaker on the existing DB dedicated to the cabinet.

#### **OPPERMANSGRONDE**

Supply and install 12U 500/100 swing frame cabinet with six-way steel power-duct with on and off button and one cooling fan, 24 Port Aruba 2540 - JL356A unmanaged PoE switch, 20Amp 6 kA CBI circuit breaker on the existing DB, install a Molex Cat6 data cable using pvc trunking, install 4 network points(mark points), Cat6 STP cable from cabinet to radio links, install a Molex Cat6 patch panel(terminate and mark points onto it), install an extended base brushed panel.


#### **PETRUSBURG**

Supply and install 12U 500/100 swing frame cabinet with six-way steel power-duct with on and off button and one cooling fan, 24 Port Aruba 2540 - JL356A unmanaged PoE switch, 20Amp 6 kA CBI circuit breaker on the existing DB, install a Molex Cat6 data cable using pvc trunking, install 7 network points(mark points), Cat6 STP cable from cabinet to radio links, install a Molex Cat6 patch panel(terminate and mark points onto it), install an extended base brushed panel.

#### LUCKHOFF

Supply and install 12U 500/100 swing frame cabinet with six-way steel power-duct with on and off button and one cooling fan, 24 Port Aruba 2540 - JL356A unmanaged PoE switch, 20Amp 6 kA CBI circuit breaker on the existing DB, install a Molex Cat6 data cable using pvc trunking, install 7 network points(mark points), Cat6 STP cable from cabinet to radio links, install a Molex Cat6 patch panel(terminate and mark points onto it), install an extended base brushed panel.
