Bid documents must be submitted in the tender box as per the details above not later than closing date and time. Bid received after the closing date and time; faxed; completed with erasable ink; incomplete or e-mailed will not be considered.

The Bid will be evaluated and adjudicated using 80/20 preference point system in line with the approved Supply Chain Management Policy of the Municipality. In terms of the Preferential Procurement Policy Framework Act 2022 and Supply Chain Regulations a maximum of 20 points may be awarded to a tenderer for the specific goal specified for the tender. Letsemeng Local Municipality will be using the following criteria to award points of these 20 points for specific goals:
