## BID CONDITIONS AND INFORMATION

### 1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by Letsemeng Local Municipality that his/her bid has been accepted.

### 2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

### 3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

### 4 Authorised Signatory

- (a) *A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.*
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

### 5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the *Tender Box at the Letsemeng Local Municipality not later than the stipulated date*
- (b) *Fixed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.*

### 6 Opening, Recording and Publications of Bids Received.

- Bids will be opened in public immediately after the bid closure date, or at such time as specified in the bid documents. If requested by any bidder present, names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out aloud.
- Bids received in time will be recorded and entered in a register which is open for public inspection.

### 7 Tax Compliance Status PIN

- a. *A Certificate showing tax compliance status pin must accompany the bid documents.*
- b. *Bids not supported by a Certificate showing tax compliance status pin, as an attachment to the bid documents will be invalidated.*
- c. *In bids where consortia/joint ventures/sub-contractors are involved, each party must submit a separate valid tax compliance pin certificate.*

### 8 Evaluation of Bids

Bids will be evaluated in terms of their responsiveness to the bid specifications and requirements as well as such additional criteria as set out in the bid documents.

Calculation of the Lowest Acceptable bid Price

### 9 Calculation of the Lowest Acceptable Bid Price for purposes of points calculation.

A price deviation percentage of 20% will be applied in order to calculate the lowest acceptable bid price. The percentage will be applied on a predetermined municipal estimated cost of the project. In calculating the estimate, the municipality will take the following factors into account, base costs, market research, industry guidelines and standards, and the approved budget vote of the municipality. The bid price that falls outside of the price deviation percentage will be disqualified on the basis of their price.

### 10 Acceptance or Rejection of a Bids

The Letsemeng Local Municipality reserves the right to withdraw any invitation to submit a bid and/or to re-advertise or to reject any bid or to accept a part of it. The Municipality does not bind itself to accepting the lowest bid.

11 **Registration on Accredited Supplier Database**  
It is expected of all prospective service providers who are not yet registered on the Central Supplier Database to register online ([www.csd.gov.za](http://www.csd.gov.za)). The Letsemeng Local Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).

12 **Site / Information Meetings**

13 **Stamp and Other Duties**  
The successful bidder will be liable for all duties and costs on legal documents resulting in the establishment of a contract and for the surety and retentions.

14 **Language of Contract**  
The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.

15 **Procurement Policy**  
Bids will be evaluated using the 80/20 preferential procurement system and awarded in accordance with the amended Preferential Procurement Regulations, 2022 pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.

16 **Expenses Incurred in Preparation of Bid**  
The Letsemeng Local Municipality shall not be liable for any expenses incurred in the preparation and submission of the bid.

17 **Wrong Information Furnished**  
Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Letsemeng Local Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

18 **Validity Period**  
*Bids shall remain valid for 90 days after the bid closure date.*

19 **General and Special Conditions of Contract**  
The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.

20 **Municipal Rates, Taxes and Charges**  
The bidder to provide their municipal account of rates and taxes of both the Bidding entity and its directors' in its Bid Document submission. Any bidder which is or whose directors are in arrear with their municipal rates and taxes due to any Municipality within South Africa for more than three months and have not made an arrangement for settlement of or same before the bid closure date will be disqualified.

21 **Contact with Municipality after Bid Closure Date**  
Bidders shall not contact the Letsemeng Local Municipality on any matter relating to their bid from the time of the opening of the bid to the time the contract is awarded. If a bidder wishes to bring additional information to the notice of the Letsemeng Local Municipality, it should do so in writing to the Letsemeng Local Municipality. Any effort by the firm to influence the Letsemeng Local Municipality in the bid evaluation, bid comparison or contract award decisions may result in the rejection of the bid.

**APPOINTMENT OF A SERVICE PROVIDER FOR THE COMPIRATION OF GRAP COMPLIANT FIXED ASSET  
REGISTER FOR A PERIOD OF THREE YEARS**

**TERMS OF REFERENCE**

**1. PROJECT BACKGROUND**

Letsemeng Local Municipality requires proposals from suitably experienced service providers to assist the Municipality with financial consultancy services and reforms, the primary aim being to obtain clean audit outcomes for the next 3 years as well as to ensure the implementation of this reform on an ongoing basis.

Sections 16 and 24 of the MFMA requires every municipality to table an annual budget at a Council meeting at least 90 days before the start of the budget year and approve that annual budget at least 30 days before the start of the budget year. While sections 122 and 126 of the MFMA requires every municipality to prepare Annual Financial Statements (AFS) and submit them for audit by 31 August each year. Letsemeng Local Municipality Local established internal departments, Budget and reporting division, expenditure division revenue division and Assets division to respectively carry out this responsibility.

In this current climate, demands for governance and transparency, implementation of mSCOA, keeping abreast with constant changes of accounting standards (GRAP) and other financial reforms, the challenges to the financial services department have never been greater. To cost-effectively address these increasing demands, there will be a need for assistance from consultants to improve data integrity and completeness of information for the compilation of the annual financial statements to be a true reflection and assist with the implementation of changes in GRAP and other financial reforms, transfer of skills to personnel to ensure efficiency, completeness and accurate reporting and upskilling of staff.

To mitigate this risk, the municipality decided to issue a three- year tender compilation of GRAP compliant fixed asset registers.

It is the intention to appoint the successful tenderer for a contract period of three years in order to ensure the success of the project and to provide the municipality with the necessary business continuity and the building of institutional knowledge and capacity.

**SCOPE OF WORK**

- a. The appointed service provider will be required to perform the functions as outlined in the different deliverables as allocated. The deliverables are summarized below:
- b. To compile a GRAP compliant Fixed Asset Register as of 30 June 2025.
- c. To compile Project implementation plan (Mobilization, Planning and Project Management).
- d. Physical identification and verification of all movable and immovable assets (Land, Buildings and Infrastructure asset) owned and controlled by the municipality.
- e. Assigning of identification numbers (bar-coding all municipal assets).
- f. Take on new assets (acquisition of assets).
- g. Compiling a list of all assets to be written off. Ensure that the required adjustments regarding disposals are captured in the asset register and recommend necessary journals.
- h. Remove all assets which were written off during the past financial years which are still on the asset register.

- i. Compiling of Work in Progress (WIP) schedule and capitalization of completed constructed projects.
- j. Reconcile Work in Progress (WIP) to pay certificates, accounting records and completion certificates.
- k. Unbundle of all completed projects.
- l. Review useful lives, residual values of assets and assess assets for impairment and prepare necessary journals.
- m. Conduct physical conditional assessment of all municipal assets.
- n. Valuation of Municipal Buildings.
- o. Perform reconciliations from the asset register to the GL to ensure that they balance.
- p. Recommend journal to correct general ledger.
- q. Determine GPS Coordinates for all movable asset and immovable assets (Land, Building and Infrastructure Assets)
- r. Perform depreciation calculation of assets and recommend necessary journals.
- s. Perform impairment calculation of assets and recommend necessary journals.

- t. Perform Depreciated Replacement Cost (DRC) calculation of assets.
- u. Prepare all assets related notes in the Annual Financial Statement
- v. Prepare appendix B & C as per the prescribed Annual Financial Statement formats.
- w. Prepare methodology documentation and present to Auditor General South Africa (AGSA)
- x. Prepare audit file, present it to CFO and sign-off by CFO.
- y. Assist with register to floor exercise of Auditor General South Africa (AGSA)
- z. Assist with floor to register exercise of Auditor General South Africa (AGSA).
- aa. Assist with communication of audit finding responses (Resolve the findings raised both current and prior year).
- bb. Update deeds data of municipal owned properties as of 30 June 2025.
- cc. Ensure that municipal officials are trained on job and skills are transferred to officials during the period of the standards.
- dd. Amend the asset register with all asset movements identified during verification exercise.
- ee. Review asset management policy with improvements for internal controls, best practice and GRAP standards.
- ff. Establish a Steering Committee and have monthly meetings with key stakeholders.
- gg. Compile close-out Report.

## **GENERAL**

- a. The services of the successful bidder shall be used as and when a need arises, during the entire duration of the tender.
- b. Based on historical data and trends, an estimated 1000 man-hours of assistance per year, may be required from the successful bidder for the successful completion of all the deliverables in the event that, assistance is required for all the deliverables.
- c. The municipality reserves the right to terminate the services, should unsatisfactory service be received from the successful bidder.
- d. The municipality reserves the right to request the appointment of the team composition in order to address a specific need or should circumstances change during the execution of the project.
- e. Monthly performance evaluation will be done, and a report submitted before any invoice submission.
- f. The successful bidder(s) will report to the Letsemeng Local Municipality Accounting Officer in relation to assignments in accordance with agreed terms as would be documented on the subsequent service level agreements or contracts. Particular projects will be initiated by means of written instructions to the successful bidders on competitive basis, backed by verbal briefings where necessary.
- g. Where an entity forms a joint venture or a consortium with another entities(y), the parties to this agreement must express in the bid proposal what aspect of the scope of work each party would be adding value to and what percentage each party will receive in terms of the proceeds flowing from any assignment.
- h. The bidders are required to ensure that the individual directors and technical staff/financial management specialist experience is clearly documented in the proposal.
- i. It is further imperative that the bidder ensures that the curriculum vitae of individual resources is not included in other bidder proposals. Should a duplication of curriculum vitae be identified across proposals, such curriculum vitae will be disregarded for both bidders during evaluation.
- j. Proposals should also clearly indicate how bidders intend to transfer skills to the Letsemeng Local Municipality finance department officials. This should particularly indicate how this was done in previous assignments.
- k. As and when assignments are agreed upon, the Letsemeng Local Municipality will stipulate the rates to be paid per consultant in terms of experience, preferable separate between trainee, junior, intermediate, and senior consultants. The Bidder is required to specifically indicate its acceptance of this condition.

- I. The bidder's staff complement must address the demographics of the country in line with government policies, and must provide evidence that it is complying with transformation in terms of Broad Based Black Economic Empowerment Act (8-BBEE)
- m. Payment will only be made upon approved deliverables. The Consultant should note that no payment will be made should the Municipality not be satisfied with the standard of deliverables.
- n. The successful bidder(s) will enter into a contractual agreement(s) with the Letsemeng Local Municipality confirming the appointment on the list of service provider.

## **APPOINTMENT OF A SERVICE PROVIDER FOR THE COMPILATION OF GRAP COMPLIANT FIXED ASSET REGISTERS FOR A PERIOD OF THREE YEARS.**

### **Pre-Qualification & Functionality Scoring:**

The following criteria will be used to calculate points for the quality of Bidders and Bidders must ensure that they submit all information to be pre-evaluated on the criteria mentioned below:

Bidders that score less than 80 out of 100 points (80%) for the pre-qualification criteria (Stage 2) will not be considered for further evaluation on Stage 3 (Price and Preference). Bidders must ensure that all the information requested is provided in detail. Unclear or incomplete information provided will result in no points being allocated. Bidders must submit applicable information for this tender. Reference to any attached documentation must be clearly indicated. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

<b>24. Termination for default</b>	<p>24.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the provider, may terminate this contract in whole or in part:</p> <ul style="list-style-type: none"> <li>(a) if the provider fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 22.2;</li> <li>(b) if the provider fails to perform any other obligation(s) under the contract; or</li> <li>(c) if the provider, in the judgement of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.</li> </ul> <p>24.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the provider shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the provider shall continue performance of the contract to the extent not terminated.</p>

<u>General Conditions of Contract</u>	
	<p>24.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.</p> <p>24.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the supplier as having no objection and proceed with the restriction.</p> <p>24.5 Any restriction imposed on any person by the purchaser will, at the discretion of the purchaser, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the purchaser actively associated.</p> <p>24.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:</p> <ul style="list-style-type: none"> <li>(i) the name and address of the supplier and / or person restricted by the purchaser;</li> <li>(ii) the date of commencement of the restriction;</li> <li>(iii) the period of restriction; and</li> <li>(iv) the reasons for the restriction.</li> </ul> <p>These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.</p> <p>24.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.</p>
<b>25. Anti-dumping and counter-vailing duties and rights</b>	25.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the provider to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the provider in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.
<b>26. Force Majeure</b>	<p>26.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the provider shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.</p> <p>26.2 If a force majeure situation arises, the provider shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the provider shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.</p>
<b>27. Termination for insolvency</b>	27.1 The purchaser may at any time terminate the contract by giving written notice to the provider if the provider becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the provider, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

<b>28. Settlement of Disputes</b>	28.1	If any dispute or difference of any kind whatsoever arises between the purchaser and the provider in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
	28.2	If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the provider may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
	28.3	Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
	28.4	Notwithstanding any reference to mediation and/or court proceedings herein,
		(a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
		(b) the purchaser shall pay the provider any monies due the provider for goods delivered and / or services rendered according to the prescripts of the contract.
<b>29. Limitation of liability</b>	29.1	Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6;
		(a) the provider shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the provider to pay penalties and/or damages to the purchaser; and
		(b) the aggregate liability of the provider to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.
<b>30. Governing language</b>	30.1	The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
<b>31. Applicable law</b>	31.1	The contract shall be interpreted in accordance with South African laws, unless otherwise specified.
<b>32. Notices</b>	32.1	Every written acceptance of a bid shall be posted to the provider concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.
	32.2	The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.
<b>33. Taxes and duties</b>	33.1	A foreign provider shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
	33.2	A local provider shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
	33.3	No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid SARS must have certified that the tax matters of the preferred bidder are in order.
<b>34. Transfer of contracts</b>	34.1	The contractor shall not abandon, transfer, assign or sublet a contract or part thereof without the written permission of the purchaser.
<b>35. Amendment of contracts</b>	35.1	No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.
