Proposals received after the closing date and time; faxed; completed with erasable ink; incomplete or e-mailed will not be considered. **The following compulsory documents must be attached: Tax Compliance Status Pin, Municipal Rates and Taxes not owing for more than 3 months or Lease agreement for both Directors and a Company indicating who is responsible for the payment of Municipal Rates and Taxes, CSD Report and Company registration documents.**

Proposals will be evaluated and adjudicated in line with the approved Supply Chain Management Policy of the Municipality 80/20 preference point system in line with the Preferential Procurement Policy Framework Act and supply chain regulations.

Firstly, the assessment of functionality will be done in terms of the evaluation criteria, A proposal which scores less than 60% for functionality will be regarded as non-responsive and will be disqualified.

Evaluation Criteria

Bidders are required to submit detailed information addressing the following:

- **Company Profile and Capability**

All relevant strengths and weaknesses of the service provider bidding for the services, including but not limited to similar previous experience, in-house technical skills, available resources, capacity, competitive advantages, and any other information that will assist Letsemeng Local Municipality in assessing the bidder's capabilities and capacity to deliver the required services.

- **Corporate Information**

A summary of the bidder's mission and vision statements, core values, and short-term and long-term strategic objectives.

- **Organisational Structure and Key Personnel**

An organogram or list of partners, managers, specialists, technicians, and support staff who will be assigned to the contract, together with detailed curriculum vitae (CVs) of personnel who will be available for the duration of the contract.

- **References**

A list of contactable references for previous and current municipalities where similar services were or are being rendered.

- **Methodology**

A clear overview of the proposed methodology and approach to be applied in executing the required services, including quality control measures, turnaround times, and reporting mechanisms.

Appointment and Second Stage (Panel Implementation)

- Service providers will be appointed to the panel for a period of three (3) years.
- The second stage of procurement will apply, whereby service providers will be requested to submit quotations as and when required.
- Appointments for Travel agency Services will be made on a rotation basis amongst the panel members, subject to compliance, availability, pricing, and performance.

The municipality is not bound to accept the lowest or any proposal and reserves the right to accept any proposal either wholly or a part thereof. - 1 Agreement**

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by Letsemeng Local Municipality that his/her bid has been accepted.
- 2 Completion of Bid Documents**
 - (a)** The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
 - (b)** Bid documents may not be retyped or altered in any way.
- 3 Alteration or Qualification of Bid**

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.
- 4 Authorised Signatory**
 - (a)** *A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.*
 - (b)** A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.
- 5 Submission of Bid**
 - (a)** The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box at the Letsemeng Local Municipality not later than the stipulated date**
 - (b)** *Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.*
- 6 Opening, Recording and Publications of Bids Received.**
 - Bids will be opened in public immediately after the bid closure date, or at such time as specified in the bid documents. If requested by any bidder present, names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out aloud.
 - Bids received in time will be recorded and entered in a register which is open for public inspection.
- 7 Tax Compliance Status PIN**
 - a.** *A Certificate showing tax compliance status pin must accompany the bid documents.*
 - b.** *Bids not supported by a Certificate showing tax compliance status pin, as an attachment to the bid documents will be invalidated.*
 - c.** *In bids where consortia/joint ventures/sub-contractors are involved, each party must submit a separate valid tax compliance pin certificate.*
- 8 Evaluation of Bids**

Bids will be evaluated in terms of their responsiveness to the bid specifications and requirements as well as such additional criteria as set out in the bid documents.

Calculation of the Lowest Acceptable bid Price
- 9 Calculation of the Lowest Acceptable Bid Price for purposes of points calculation.**

A price deviation percentage of 20% will be applied in order to calculate the lowest acceptable bid price. The percentage will be applied on a predetermined municipal estimated cost of the project. In calculating the estimate, the municipality will take the following factors into account, base costs, market research, industry guidelines and standards, and the approved budget vote of the municipality. The bid price that falls outside of the price deviation percentage will be disqualified on the basis of their price.
- 10 Acceptance or Rejection of a Bids**

The Letsemeng Local Municipality reserves the right to withdraw any invitation to submit a bid and/or to re-advertise or to reject any bid or to accept a part of it. The Municipality does not bind itself to accepting the lowest bid.

- 11 Registration on Accredited Supplier Database**
It is expected of all prospective service providers who are not yet registered on the Central Supplier Database to register online (www.csd.gov.za). The Letsemeng Local Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).
- 12 Site / Information Meetings**
- 13 Stamp and Other Duties**
The successful bidder will be liable for all duties and costs on legal documents resulting in the establishment of a contract and for the surety and retentions.
- 14 Language of Contract**
The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.
- 15 Procurement Policy**
Bids will be evaluated using the 80/20 preferential procurement system and awarded in accordance with the amended Preferential Procurement Regulations, 2022 pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.
- 16 Expenses Incurred in Preparation of Bid**
The Letsemeng Local Municipality shall not be liable for any expenses incurred in the preparation and submission of the bid.
- 17 Wrong Information Furnished**
Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Letsemeng Local Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.
- 18 Validity Period**
Bids shall remain valid for 90 days after the bid closure date.
- 19 General and Special Conditions of Contract**
The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.
- 20 Municipal Rates, Taxes and Charges**
The bidder to provide their municipal account of rates and taxes of both the Bidding entity and its directors' in its Bid Document submission. Any bidder which is or whose directors are in arrear with their municipal rates and taxes due to any Municipality within South Africa for more than three months and have not made an arrangement for settlement of or same before the bid closure date will be disqualified.
- 21 Contact with Municipality after Bid Closure Date**
Bidders shall not contact the Letsemeng Local Municipality on any matter relating to their bid from the time of the opening of the bid to the time the contract is awarded. If a bidder wishes to bring additional information to the notice of the Letsemeng Local Municipality, it should do so in writing to the Letsemeng Local Municipality. Any effort by the firm to influence the Letsemeng Local Municipality in the bid evaluation, bid comparison or contract award decisions may result in the rejection of the bid.

TERMS OF REFERENCE

PROVISION OF TRAVEL AGENCY SERVICES FOR LETSEMENG LOCAL MUNICIPALITY AS AND WHEN REQUIRED FOR A PERIOD OF THREE YEARS

1. PURPOSE

The Letsemeng Local Municipality (LLM) seeks to appoint a service provider who shall secure the services of a Travel Agent for the provision of travel agency services in respect of Air Travel, Car Hire, Accommodation, venue hire and related travel agency services in line with the National Treasury Cost Containment Regulations as amended from time to time, LLM Subsistence & Travel Policy as well as the LLM Cost Containment Policy as approved by Council, as and when required.

2. OVERALL GOAL AND OBJECTIVES

2.1 The objective of this tender is to allow the LLM to use its leverage and to use its consolidated spend information to optimize procurement outcomes.

2.2 LLM has identified the goals to be achieved as follows:

- a) To develop a sound service delivery model to efficiently and effectively manage the provision of travel agency services for the LLM;
- b) To ensure that procured services are tailored to satisfy the needs and requirements of the user departments;
- c) To enter into a formal service contract with the successful bidder in a manner commensurate with Supply Chain Management (SCM) principles;
- d) Optimize procurement spend within the sphere to ensure value for money;
- e) To ensure that all travel, accommodation, venues and facility arrangements are only for official purposes and in the best interest of LLM;
- f) To ensure high quality travel agency services on a 24-hour basis for the duration of the contract;
- g) To ensure that the most cost effective and practical means of travel and accommodation is used at all times based on the municipality's subsistence and travel policy and the Cost Containment Regulations;
- h) To assist the LLM's booking officials with all their travel and accommodation arrangements; and
- i) To ensure the best possible discounts on the procurement of air tickets and accommodation.

3. SCOPE OF WORK

The municipality's requirements for domestic and/or international travel, vehicle rental and accommodation cover the following:

3.1 Air Travel

The successful bidder shall be required to:

- 3.1.1 Plan, arrange or amend air travel bookings at the lowest fare available, both domestic and international, including the issuing and delivery of any travel documentation to the officials who are to travel;
- 3.1.2 Negotiating discounts on standard tariffs for air travel with all available airline companies on behalf of the LLM;
- 3.1.3 To manage and advise the LLM on the issuing and utilization of voyager miles/points accumulated; and
- 3.1.4 Arrange lounge access only where permitted by the LLM Subsistence & Travel Policy or explicitly approved

3.2 Travel Related Transport

The Successful Bidder shall be required to:

- 3.2.1 Arrange vehicle hire strictly in accordance with the Letsemeng Local Municipality's Subsistence & Travel Policy, National Treasury Cost Containment Regulations, and all related instructions, circulars and amendments issued from time to time;
- 3.2.2 Ensure that relevant information is shared with travellers regarding rental vehicles, like e-tolls, refuelling, keys, rental agreements, damages and accidents, etc;
- 3.2.3 Advise the Traveller on the best time and location for collection and return considering the Traveller's specific requirements
- 3.2.4 Book a shuttle to and from the accommodation establishment;
- 3.2.5 Negotiating discounts on standard rates with all available companies on behalf of the LLM.
- 3.2.6 Vehicle hire bookings must:
 - a) Be limited to the approved vehicle categories as prescribed in the LLM Subsistence & Travel Policy;
 - b) Exclude luxury, premium or upgraded vehicle classes unless expressly approved in writing by the Accounting Officer or delegated authority;
 - c) Be based on the most cost-effective rate available for the approved vehicle category.
- 3.2.7 The successful bidder may not process or allow vehicle upgrades, optional extras or premium vehicle selections unless prior written approval is obtained from the Municipality. Any unauthorised upgrade costs shall not be recoverable from the Municipality.
- 3.2.8 Vehicle hire duration must be strictly limited to the official period of travel. Early collection or late return resulting in additional costs shall not be permitted unless properly motivated and approved in advance.
- 3.2.9 The successful bidder shall not procure additional insurance waivers or excess reduction products unless expressly approved in writing.

3.3 Accommodation

The successful bidder shall be required to:

- 3.3.1 Plan, book or amend accommodation with any hotel group, private hotel or other available concern, i.e. a guesthouse or Bed & Breakfast, where such a requirement is referred to the travel agent;
- 3.3.2 Identify accommodation in small towns as and when required and ensuring that there is some understanding of the quality of the service that may be expected in such as well as to consider alternatives to mainstream accommodation chains;
- 3.3.3 Accommodation bookings must be made at hotels, guest houses and Bed & Breakfasts which have a rating of at least 3-star rated accommodation where available, failing which written motivation and approval shall apply;
- 3.3.4 The municipality may also require the travel agent to make bookings at hotels specifically chosen by the municipality in instances where travel time and cost is to be minimized.
- 3.3.5 Negotiating discounts on standard tariffs or reduced tariffs with all available hotel groups, private hotel or other concern.

3.3.6 Prohibition of Cashing-In, Conversion or Abuse of Meals

- 3.3.6.1 Accommodation bookings must strictly comply with the LLM's Subsistence & Travel Policy, LLM Cost Containment Policy and National Treasury Cost Containment Regulations.
- 3.3.6.2 The following practices are strictly prohibited:
 - a) The conversion of meals included in accommodation packages into cash, vouchers, refunds, discounts, credits or any other personal benefit to the traveller;
 - b) Invoicing the Municipality for meals not actually consumed by the traveller;
 - c) Inflating accommodation invoices to offset or disguise meal costs;
 - d) Any arrangement between travellers and accommodation establishments that results in unauthorised personal gain.
- 3.3.6.3 The successful bidder shall ensure that:
 - a) Accommodation invoices clearly and separately reflect accommodation charges and meal charges, where applicable;
 - b) No meals are invoiced unless they are legitimately included in the approved booking and actually consumed; and
 - c) All accommodation bookings are aligned to approved subsistence limits.

1. Definitions	1. The following terms shall be interpreted as indicated: 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids. 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein. 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations. 1.4 "Corruptpractice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution. 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally. 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. 	22.4 Except as provided under GCC Clause 25, a delay by the provider in the performance of its delivery obligations shall render the provider liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties. 22.5 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the provider's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the provider.
23. Penalties	23.1 Subject to GCC Clause 25, if the provider fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

24. Termination for default	24.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the provider, may terminate this contract in whole or in part: (a) if the provider fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 22.2; (b) if the provider fails to perform any other obligation(s) under the contract; or (c) if the provider, in the judgement of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract. 24.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the provider shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the provider shall continue performance of the contract to the extent not terminated.

General Conditions of Contract	
	24.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years. 24.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the supplier as having no objection and proceed with the restriction. 24.5 Any restriction imposed on any person by the purchaser will, at the discretion of the purchaser, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the purchaser actively associated. 24.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information: (i) the name and address of the supplier and / or person restricted by the purchaser; (ii) the date of commencement of the restriction; (iii) the period of restriction; and (iv) the reasons for the restriction. These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector. 24.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.
25. Anti-dumping and counter-vailing duties and rights	25.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the provider to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the provider in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.
26. Force Majeure	26.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the provider shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure. 26.2 If a force majeure situation arises, the provider shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the provider shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.
27. Termination for insolvency	27.1 The purchaser may at any time terminate the contract by giving written notice to the provider if the provider becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the provider, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

General Conditions of Contract	
28. Settlement of Disputes	28.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the provider in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation. 28.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the provider may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party. 28.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law. 28.4 Notwithstanding any reference to mediation and/or court proceedings herein, (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and (b) the purchaser shall pay the provider any monies due the provider for goods delivered and / or services rendered according to the prescripts of the contract.
29. Limitation of liability	29.1 Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6; (a) the provider shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the provider to pay penalties and/or damages to the purchaser; and
	(b) the aggregate liability of the provider to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.
30. Governing language	30.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
31. Applicable law	31.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified.
32. Notices	32.1 Every written acceptance of a bid shall be posted to the provider concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice. 32.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.
33. Taxes and duties	33.1 A foreign provider shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country. 33.2 A local provider shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser. 33.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid SARS must have certified that the tax matters of the preferred bidder are in order.
34. Transfer of contracts	34.1 The contractor shall not abandon, transfer, assign or sublet a contract or part thereof without the written permission of the purchaser.
35. Amendment of contracts	35.1 No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.
